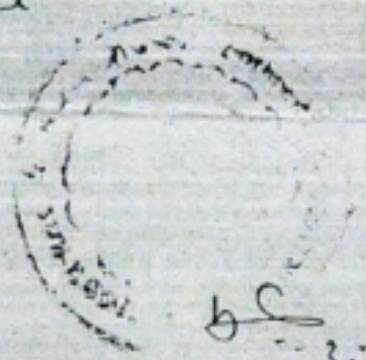



All the remaining members shall be entitled to appoint another member in place of the deceased member if mutually agreed upon and the members so appointed shall be put on the same position with that of other surviving members of the Board as if he/she or they were originally appointed and/or constituted.
